**Corporate Membership** - Any entity that provides motor industry/auto industry related services to any such General Membership as defined above. An Annual Subscription Fee of \$195 (+ gst) is payable in advance by 1 July of each year where membership is active.

**Individual Industry Professional Membership** - An individual that has been invited by the Committee, or nominated by an existing Member for Committee approval, with automotive industry knowledge, expertise, experience that can provide value to the Society and its members. There is no Annual Subscription Fee payable, however Annual Renewal is at the discretion of the Committee. This membership also does not qualify for access to ownership information on the MVR under NAITA's authorisation.
